



APPEAL/COMPLAINT FOR NOT PROVIDING THE INFORMATION AGAINST RTI NO. PCS/2016/DTOASR/0113/01352 DATED 03/05/2016 -SHOWS DERELICTION OF DUTY AND MALAFIDE INTENTION TOWARDS THE HON'BLE PARLIAMENT/COMMISSION.

Sir,

I, the Appellant/Complainant [P. C. Sharma, Advocate/RTI & Social Activist], sought simple information from The District Transport Officer/PIO, AMRITSAR. The DTO/PIO has not provided the information intentionally, reason being well known to her. The act of the PIO shows **dereliction of duty & malafide intention** towards the Hon'ble Parliament/Commission.

It is pertinent to the mention here that the said DTO/PIO is violating the RTI Rules, which tantamount to the abuse of the authority. Furthermore the PIO cannot claim the photo copy charges for the documents, if the information is not provided by her within 30 days.

That in view of the facts mentioned above, it is therefore requested that the following relief may kindly be granted in favor of the appellant/complainant and against the PIO.

1. Directions may be given to the DTO/PIO to provide me the legible, attested, correct, accurate & complete information as is mentioned in my application dated 03/05/2016 without any further delay.
2. That the action may be recommended for departmental proceedings against the PIO or deemed PIO under section 20 [1] & 20[2] of the RTI Act, 2005.
3. Directions may be given to the DTO/PIO not to harass the appellant/complainant like this way.

The above menace and un-orderly driving of Tractors/Trolleys has been gradually increasing and has now almost become a public nuisance due to utter failure on the part of the Traffic Police, Transport & Municipal authorities. It has come to notice that the drivers of the said ~~Tractors/Trolleys may not have valid Driving License to drive the Tractors/Trolleys nor~~ observe any traffic rules, while driving.
