1. Introduction: About the Department

The Transport Department, with an objective to reduce the accidents/fatalities, for better service delivery with more transparency and accountability, intends to establish 6 automotive testing stations (ATS) in Punjab on BUILD, OWN and OPERATE (BOO) basis in the state of Punjab

Ministry of Road Transport & Highways (MoRTH) New Delhi issued a notification No.G.S.R.652(E) dated 23.9.2021 (Effective from 25.9.2021) for the recognition, regulation & control of Automated Testing Stations. As per the said notification the vehicle fitness testing may be conducted through the Automated Vehicle Testing equipment in accordance with the provisions of this notification.

3. Pre-Qualification Criteria

- 1) As per rule 176 of the notification No.G.S.R.652(E) dated 23.9.2021 and any other instructions issued by the Ministry of Road Transport & Highways (MoRTH) New Delhi from time to time, the owner or operator of an automated testing station shall possess, -
 - a) certificate of Incorporation or Shop Act registration or Udyam Aadhaar;
 - b) valid Goods and Service Tax certificate; and
 - c) valid Permanent Account Number.
 - d) The owner or operator of an automated testing station shall have a minimum net worth of Rupees three Crore during the last financial year and should have a positive profit after tax in the last two financial years.
 - e) The premises where the automated testing station is to be housed shall either be owned or taken on lease or hired by the owner for a period of not less than ten years, shall have the connectivity of two lane road for smooth flow of heavy vehicles and have parking area of half acre per testing lane.

Based on the round table discussions and proposals submitted by the applicants in the EoI, the Department shall proceed further so as to determine in the most transparent and economic manner for the establishment of 6 Automotive Testing Stations (ATS) in Punjab on BUILD, OWN and OPERATE (BOO) basis in the State of Punjab. The Department reserves the right to amend or cancel the EoI at any stage.
