No. 2/32/07-2T2/1047624/1 In supersession of the Government of Punjab, Department of Transport, Notification No. 2/32/07-2T(2)/645976/1 Dated 11th December, 2015 whereas Government considering that for the convenience of the Transport Vehicle Operators viz., Stage Carriage Operators, it is necessary for an operator to keep his transport vehicle mechanically fit as required under the Motor Vehicles Act, 1988, therefore, in pursuance of provision of Section 13(3) of the Punjab Motor Vehicles Taxation Act, 1924, and all other powers enabling him in this behalf, the Governor of Punjab is pleased to allow exemption from immediate effect as under in a year from the payment of Motor Vehicles Tax payable under Section 3 of the Act, to a person having stage carriage permit in the public interest. This facility shall be available to all stage carriages big buses in Punjab State only.
