In this behalf and in supersession of the Government of Punjab, Department of Transport, Notification No.2/12/2016-4T2/1420 dated 02.12.2016 the Governor of Punjab, hereby issues to the State Transport Authority, Punjab the following direction regarding revision of rate of fare for buses to be run under the BRTS scheme at Amritsar in the State of Punjab as under:-

KM Slab	Bus Fare prices for AC BRTS Amritsar
0 to 3	5
Above 3 & upto 6	10
Above 6 & upto 12	15
Above 12 & upto 20	20
Above 20	Rs 20 + Re 1 per KM

Daily Passes for unlimited trips between any destinations valid for a single date

2	Others	Rs.50/-

1 (b)	Students Concessional Fare - School Students	100%	Rs 50 (Non Refundable Personalized Card)	Free
2	General public - Smart card holders	20% Discount	Rs 50/- (Refundable if card is returned in working condition)	The minimum recharge amount for general category shall be Rs 200/-
