No.2/32/07-2T(2)/ 645976/1.- In supersession of the Government of Punjab, Department of Transport, order No. 2/32/07-2T(2)/1795 dated 12<sup>th</sup> October, 2012 whereas Government considering that for the convenience of the Transport Vehicle Operators viz., Stage Carriage Operators, it is necessary for an operator to keep his transport vehicles mechanically fit as required under the Motor Vehicles Act, 1988, therefore, in pursuance of provision of Section 13 (3) of the Punjab Motor Vehicles Taxation Act, 1924, and all other powers enabling him in this behalf, the Governor of Punjab is pleased to allow exemption from immediate effect as under in a year from the payment of Motor Vehicles Tax payable under Section 3 of the Act, to a person having stage carriage permit in the public interest. This facility shall be available to all stage carriages big buses registered in Punjab State only.

No. 2/32/07-2T2/645972 | Due to road blocked by the general public in the month of October, stage carriage buses could not be operated by the bus operators of Punjab State, therefore, in pursuance of provision of Section 13 (3) of the Punjab Motor Vehicles Taxation Act, 1924, and all other powers enabling him in this behalf, the Governor of Punjab is pleased to allow ten days exemption in the month of October, 2015 for the payment of Motor Vehicle Tax payable under Section 3 of the Act. During the month of October, 2015, the five days exemption of Motor Vehicles Tax shall continue as specified vide order No. 2/32/07-2T2/1795 dated 12<sup>th</sup> October, 2012. The Motor Vehicles Tax already paid by the bus operators during the month of October, 2015, the amount of these ten days exemption of Motor Vehicle Tax shall be adjusted in the payment of next month.


